

MINUTES OF SAMPFORD COURTENAY ANNUAL GENERAL PARISH COUNCIL MEETING

Date and Venue – WED 17th May 23 7.00 pm at Sampford Courtenay Village Hall

- 1. **Chair** Cllr M Wilson welcomed the members of the public and new and old councillors to the meeting. **Clerk M Pratt** -now chaired the meeting until the election of the new Chair.
- 2. **Declaration of Acceptance of Office by all councillors** all signed in presence of the Clerk
- 3. **Declaration of Interests of all councillors –** Declarations have currently been received from 7/8 councillors.
- 4. **Declaration of Election Expenses by all councillors** Declarations of Election Expenses have currently been received from 6/8 councillors.
- 5. Election of Chairperson
 - Cllr P Collins proposed Cllr M Wilson as Chair; seconded by Cllr M Carpenter.
 - Cllr C Coleman said he would like to see a contested election of Chair; and asked Cllr J Mcllwraith to put himself forward; seconded by Cllr Coleman.
 - Cllr Coleman proposed that this should be by secret nominated ballot Councillors voted on this proposal and it was defeated by 6 votes to 2.
 - Therefore, a vote by show of hands was taken and Cllr M Wilson was elected Chair by 5 votes to 2 with Cllr Wilson abstaining.
- 6. **Adoption of Code of Conduct** (already circulated) Adoption proposed by Cllr P Collins, seconded Cllr M Carpenter carried unanimously.
- 7. **Signing of Acceptance of Office Form by newly elected Chairperson –** Cllr Wilson now signed her Acceptance of Office of Chair form.

- 9. **Election of Vice Chairperson.** Cllr P Collins proposed Cllr M Carpenter for Vice Chair, seconded by Cllr M Morrissey carried by 7 votes to 1 abstention.
