

Notes

- Existing access door to unisex wheelchair accessible toilets might need to be converted into a power operated door - tbc
- width of ramp is not compliant, but there is limited possibility to improve with existing site constraints - suggest an initial consultation with Building Control to agree a compromise.
- 2no. steps up into community space, existing door to be relocated with a small 'nib' wall required to provide door jamb.
- initial ramp from lane goes across a sloping surface, some making good is required to the lane to accommodate ramp.
- suggestion to relocate the existing gate as a feature against the back wall, to allow the full unobstructed width for the ramp.
